

DRAWING RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

The Giving Hearts Day Giveaway starts on January 3, 2022, at 8:00 a.m. Central Time and ends on January 17, 2022, at 11:59 p.m. Central Time.

1. **ELIGIBILITY:** This drawing is offered by Gate City Bank. There is no purchase, entry fee or payment necessary to nominate a charity, for a charity to win the random drawing, or to obtain information about the Giveaway. This drawing is open to legal residents of the United States who are eighteen (18) years or older at the time of entry. Void where prohibited by law. Giveaway is subject to all applicable federal, state and local laws.

All entries must be received by 11:59 p.m. Central Time on January 17, 2022, to be eligible. 2. **RANDOM DRAWING:** On or about January 18, 2022, five (5) winning charities will be selected in a random drawing from all eligible entries received throughout the Giveaway period. Odds of winning depend on the number of eligible entries received. Gate City Bank decisions are final and binding.
